We look forward to continuing to work with local agencies, synagogues, and donors to support our community now and in the future.

This past year, the Jewish Foundation distributed over \$3.9 million to charitable organizations, of which, 82% was distributed to local Jewish organizations—our synagogues, the Jewish Federation, for Jews in need and Jewish Family Service, the Jewish Historical Society, the Jewish Cemetery Association, for the frail and elderly and the Towers, Ezra Academy, Southern Connecticut Hebrew Academy, Camp Laurelwood and the JCC, BBYO, the ADL, for local synagogue school scholarships, for security for our local organizations, PJ Library and for Jewish education.

We continue to grow. We continue to fund Jewish New Haven. We continue to be a philanthropic and endowment resource and partner for our synagogues and agencies, for professional advisors, for individual donors, families, foundations, and for the community.

In the fall we relaunched our Create a Jewish Legacy New Haven initiative, supported by the Harold Grinspoon Foundation, which partners with 14 of our local organizations to enable them, through group trainings, resources, and individual consulting, to secure their futures by building their legacy and endowment programs.

We also counsel individuals and facilitate family discussions to assist donors in their philanthropy and planned giving, as well as to educate them on local needs and impact.

We invest in the next generation through our One Happy Camper Initiative, with scholarships to programs in Israel, through our security grants, and our funding of the Jewish Federation of Greater New Haven which received over \$500,000 for their 2022 annual campaign from Jewish Foundation PACE and LOJE endowments as well as \$174,750 for community grants for our local organizations.

Thank you for considering us as your partner and resource. Together we impact lives and make a difference in our community.

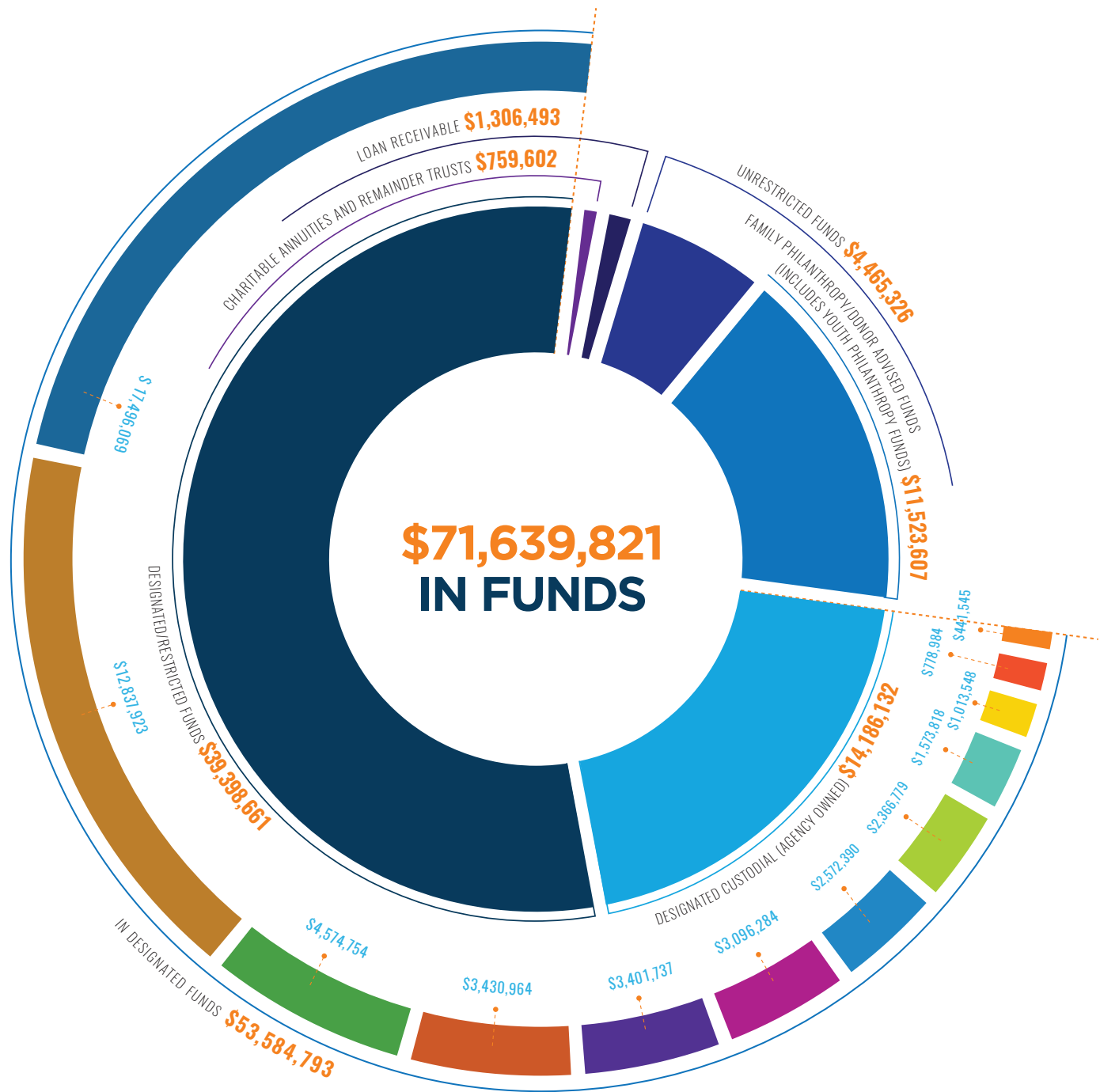

INVESTMENT & MANAGEMENT

For the fiscal year ending December 31, 2022, the Foundation's managed portfolio had a one-year rate of return of (12.19%), a three-year rate of return of 9.62%, and a five-year rate of return of 9.12%.

In January 2017, following an extensive request for proposal (RFP) process by the Foundation's Investment Committee, the Foundation's board of trustees engaged SCS Financial to serve as the new investment advisor for the Jewish Foundation. One of the goals of engaging SCS was to combine both tactical and strategic advising to ensure ongoing, proactive, and timely portfolio strategy implementation within the Investment Policy Statement established by the Investment Committee, accompanied by excellent manager selection, asset allocation strategy, and sophisticated portfolio exposures.

The Foundation's Investment Committee, in consultation with the outside independent investment advisor, established an allocation strategy and long-term outlook for the investment and management of the Foundation's endowment funds that will target a total return (income plus capital change) that will preserve and enhance (in real dollar terms) the principal value of the funds and provide a dependable source of support for current operations and programs. The Foundation's long-term approach to endowment spending has sought to maintain and grow each endowment fund while providing the beneficiary organization with consistent distributions.

ASSET ALLOCATION

The Foundation has continued to maintain a moderately conservatively positioned portfolio, which is well-diversified, constantly monitored, and strategically rebalanced.

SPENDING POLICY

Each year, the board of trustees of the Jewish Foundation approves a prudent spending policy that is applied to all unrestricted funds as well as Foundation-owned restricted funds. The spending policy is developed in consultation with our investment advisor, as well as the Foundation's Finance and Investment committees.

In making its decision for 2022, the board follows the Uniform Prudent Management of Institutional Funds Act and approved a spending policy that takes into account the uses, benefits, purposes, and duration of the endowment. The current spending policy is 4.0% of a fund's average fair market value for the rolling prior 12 quarters.

PACE funds make an impact – this year, \$517,000 will be distributed to the annual campaign from PACE/LOJE funds.

Your Jewish legacy can be created during your lifetime with cash, stock, or retirement assets. You can also make a commitment now to establish or add to your fund through your estate or with insurance or retirement assets.

In 2008, there was \$1.2 million in PACE and LOJE funds. Today, there is over \$17 million, and in addition, there is another \$2 million in commitments to PACE and LOJE!

ABOUT THE CHALLENGE

Established in partnership with the Beckerman Family Foundation, the \$2 million Beckerman Family PACE Challenge is a 1:1 match intended to secure the future of the Greater New Haven Jewish community through newly established and increased Perpetual Annual Campaign Endowment (PACE) funds: \$1 million to be comprised of new PACE funds, and the other million dollars to be from additions to existing PACE funds.

WHAT IS PACE?

A **Perpetual Annual Campaign Endowment (PACE)** fund is a permanent endowment fund of the Jewish Federation of Greater New Haven established in your name to perpetuate your annual commitment to the Federation's Annual Campaign. As an endowment fund, principal is not touched and the fund is invested with the Jewish Foundation of Greater New Haven. Each year, the interest earned from the fund is distributed to the Federation's Annual Campaign. The annual distribution will be made in perpetuity in your name.

HOW DOES IT WORK?

Anyone can start an endowment fund, no matter your financial situation. The minimum amount required to start a fund is \$10,000, but it doesn't need to be fully funded up-front. An endowment can be funded over time through periodic donations (a great way to mark a milestone or special occasion!) or with a single gift. Donations can be made in the form of cash, stock, and/or planned gifts, such as a bequest in your will, or an IRA or life insurance designation.

Did You Know:
A Women's Philanthropy gift can also be endowed as a special type of PACE fund called a LOJE (or Lion of Judah Endowment)!

The money contributed is used to establish a Perpetual Annual Campaign Endowment fund in your name. The fund is invested in Federation's Endowment Foundation for long-term growth. Each year, a distribution is made from your PACE fund to Federation to perpetuate your annual support.

WHY SHOULD I OPEN A PACE FUND?

Reason #1: PACE Funds account for a sizeable (and growing!) portion of Federation's Annual Campaign.

When David and Ruthann Beckerman first helped launch PACE in the Greater New Haven community back in 1999, PACE fund disbursements accounted for just under \$20,000 towards a \$3.17 million annual campaign, or a little more than 0.6% of all donations to that year's campaign.

Last year, PACE funds paid out \$517,000 into a \$2.39 million campaign, or nearly 22% of all monies raised! And if you start a PACE fund today, we can ensure that number continues to grow to provide a strong foundation for our community's future.

Reason #2: Starting a PACE Fund is a win-win scenario!

When you open a PACE fund at the Jewish Foundation, not only does it provide benefits to the Jewish community for decades to come, it also benefits you! Here are some of the ways:

- **Recognition.** You are recognized as a PACE donor when you announce your commitment to make this enduring gift.
- **Tax Benefits.** You may receive estate and/or income tax benefits depending on your specific situation and the funding method chosen.
- **Impact.** Your gift will generate future income to support Federation.

- **Values.** This gift makes a statement to your children and grandchildren about your Jewish values and commitment to Jewish life and continuity.

HOW DO I ESTABLISH A PLANNED OR LEGACY GIFT?

There are a variety of vehicles you can use, such as securities, retirement plan assets, real estate, charitable gift annuities, charitable remainder trusts, and gifts of life insurance.

Here are just some of the options available to you:

- Donate cash or securities during your lifetime
- Leave a gift to Federation in your will
- Gift a new or existing life insurance policy by naming Federation as owner and beneficiary of the policy
- Complete a Beneficiary Designation Form with your IRA administrator which lists Federation as a beneficiary
- Include Federation as a charitable beneficiary of your donor-advised Fund after your lifetime

CAN THE FEDERATION WORK WITH MY FINANCIAL ADVISORS?

Absolutely! It's important to consult with your financial advisor before making any planned or legacy gifts. In partnership with the Jewish Foundation of Greater New Haven, Federation will work with you and your professional advisors to plan a gift that achieves your personal financial and charitable goals. Federation is available to meet and consult with you and your advisors throughout the process.

“It's a question of priorities. Our priority is to ensure the future of our Jewish community. What we need to do is to build a very stable and strong foundation. And that comes from an endowment fund.”

CREATE A JEWISH LEGACY

This past fall, the Jewish Foundation of Greater New Haven held a kickoff meeting and information session on Zoom to announce its second Create a Jewish Legacy initiative in partnership with the Harold Grinspoon Foundation's LIFE & LEGACY® program. A strong start to the program, the kickoff was attended by nearly 60 representatives of Jewish organizations in Greater New Haven and resulted in the commitment of 14 synagogues and agencies to the initiative (on page 14).

Launched nationally by the Grinspoon Foundation in 2012, LIFE & LEGACY provides training, support, and monetary incentives to help Jewish organizations, agencies, and synagogues secure their individual financial futures by spearheading their own endowment and bequest drives. Greater New Haven was one of the very first communities selected to participate in this important program in 2012, and between 2013 and 2016 the Jewish Foundation distributed over \$300,000 in incentive grants to participating local Jewish organizations and synagogues and secured legacy commitments from over 375 households, totaling an estimated \$8.1 million. The program solidified the strong partnership between the Jewish Foundation and the synagogues, agencies, and organizations in Greater New Haven.

Today, LIFE & LEGACY has expanded to more than 70 communities nationwide and has secured over \$1.24 billion in commitments, making a transformative impact on the American Jewish community. The Jewish Foundation's

second 4-year Create a Jewish Legacy initiative officially began on January 1, 2023, and aims to steward, sustain, and build on all that we have already accomplished together as well as to further assist our organizations in integrating legacy giving into their culture.

"The Harold Grinspoon Foundation is thrilled to continue its partnership with the Jewish Foundation of Greater New Haven. The work of the Jewish Foundation and participating organizations over the last 10 years has truly transformed giving in the community," said Arlene D. Schiff, Senior Advisor of LIFE & LEGACY at the Harold Grinspoon Foundation. Schiff added, "However, while legacy giving is in many ways part of the community's philanthropic culture, there is more work to do for it to become normative behavior. We want every member of

or donor to a Greater New Haven Jewish organization to have the opportunity to make a gift that will ensure the Jewish community remains strong and vibrant for future generations."

Funded equally by the Grinspoon Foundation and the Jewish Foundation, Create a Jewish Legacy Greater New Haven has a twofold mission: First, to support past partner organizations in stewarding their existing donors and securing new legacy commitments; and second, to engage organizations and synagogues that did not participate in the previous program to safeguard their long-term financial health. To achieve this mission, the Jewish Foundation will distribute \$170,000 in incentive grants over the next 4 years, host local and national professional training sessions in

375 households have committed **\$8.1 MILLION** for local Jewish organizations.

partnership with the Grinspoon Foundation, and provide consulting, marketing, and publicity resources to the participating organizations.

“The Jewish Foundation of Greater New Haven and the Harold Grinspoon Foundation were instrumental in our ability to launch Temple Emanuel’s first successful legacy program,” said Ed Cantor, past President of Temple Emanuel in Orange. He continued, “The campaign would not have happened without their guidance and resulted in the Temple receiving pledges from about 25% of our membership. We look forward to taking part in the next round.”

In addition, the Jewish Foundation recently hired a new community professional, Tamara Schechter, as the first Create a Jewish Legacy Manager. Along with Lisa Stanger, Executive Director of the Jewish Foundation, Tamara assists each agency to develop a personalized plan, implement action, and track progress, ensuring their successful participation in the program.

“This is what the Jewish Foundation does—we assist our local Jewish agencies and synagogues to raise endowment dollars and we advise our professional advisors and donors on philanthropic giving. We are so fortunate to have Tamara as part of our team and to have an organization like the Grinspoon Foundation supporting us,” stated Stanger.

By building the current and future endowments for our community organizations, Create a Jewish Legacy Greater New Haven continues to advance Jewish life in New Haven, sustaining valued organizations and vibrant Jewish communities for the next generation and beyond. ♻️

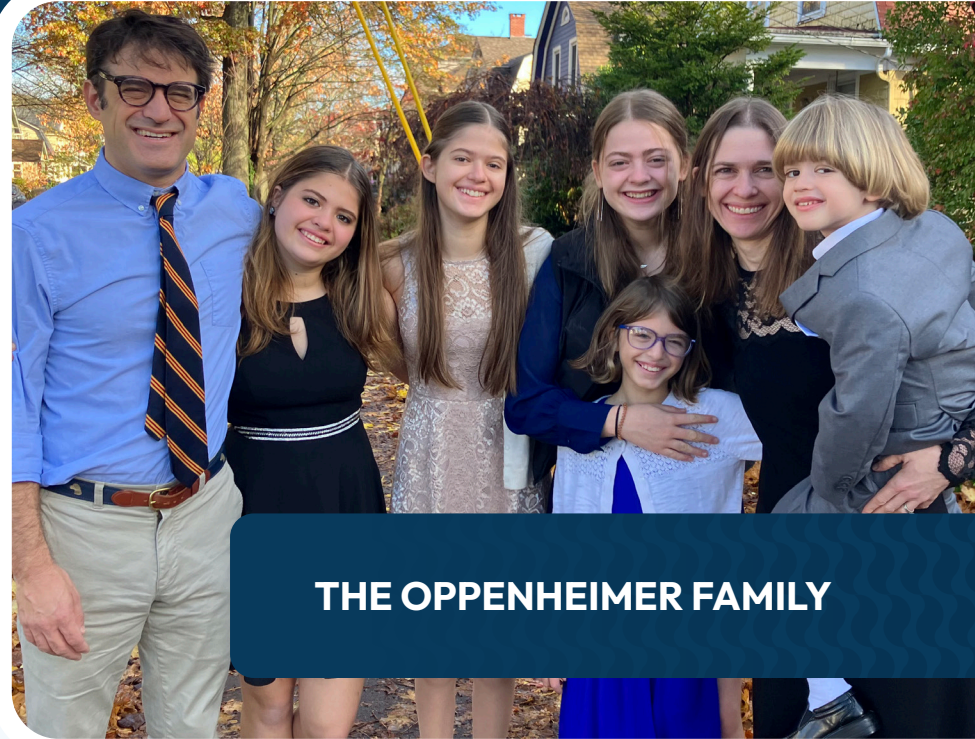

FOUNDATION PROGRAMS & INITIATIVES

DONOR-DESIGNATED FUNDS FOR SYNAGOGUES AND AGENCIES

The Jewish Foundation works with donors, agencies, and synagogues to solicit and cultivate new restricted endowment funds through current gifts, bequests, trusts, or annuities.

For existing funds, the Foundation provides the donor and the beneficiary organization with quarterly personalized fund reports, provides the beneficiary organization with annual distributions, and works with the beneficiary organization to provide the donor with ongoing stewardship.

The Foundation also serves as a resource for policies, regulations, and laws pertaining to charitable giving as well as the investment and management of endowment funds.

YOUTH PHILANTHROPY AND BUILD A TZEDAKAH FUNDS

The Foundation administers and promotes the Build a Tzedakah Fund program, which enables young adults to establish their own Foundation endowment fund.

The Build a Tzedakah program allows young adults to engage in charitable giving by contributing \$600 from their bar or bat mitzvah gifts, with a match of \$400 from a community donor.

With this, the young adult now has a \$1,000 named charitable fund at the Jewish Foundation—he or she, or others, can add to the fund at any time and in honor of special occasions – and every December (Hanukkah time), he or she will be given the opportunity to choose to which charity(ies) he or she wants to make a distribution (distributions are based on the Jewish Foundation's spending policy).

Over the past 15 years, Build a Tzedakah funds have distributed over \$80,000 to more than 80 organizations!

ISRAEL AND OVERSEAS ENDOWMENT FUNDS

The Jewish Foundation holds restricted endowment funds that guarantee that our community will continue to support Israel and Jewish communities in need overseas. These funds make annual distributions to the Jewish Agency for Israel (JAFI), to the American Jewish Joint Distribution Committee (JDC), and/or to donor-designated charitable organizations that support Israel and Jews in need overseas.



SCHOLARSHIPS

The Jewish Foundation offers scholarships for college, synagogue schools, Jewish overnight camp, and programs in Israel. *See pages 24–25 for more information, or go to jewishnewhaven.org/scholarships.*

CREATE A JEWISH LEGACY

Through Create a Jewish Legacy New Haven, funded in part by the Harold Grinspoon Foundation, the Jewish Foundation provides resources, training, expertise, and incentive grants to our local Jewish organizations and synagogues to assist them in building their endowments and securing legacy gifts. *See pages 12–17 for more information.*

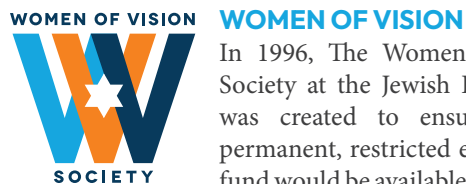

HELPING THOSE IN NEED: THE MAIMONIDES AND DEVORAH FUNDS

The Maimonides and Devorah Funds at the Jewish Foundation continue to provide anonymous financial assistance for emergencies and/or medical needs, as requested by our rabbis, Jewish Family Service, and other referring agencies.

MATAN B'SETER מתן בסתר Giving in Secret

Both funds were established to follow the precepts of Rabbi Moshe Ben Maimon (better known as Maimonides), who, in defining levels of tzedakah (charity), deemed one of the highest levels to be *matan b'seter* (giving in secret). This is when the benefactor has no knowledge of the recipient, and the latter has no knowledge of the donor.



In 1996, The Women of Vision Society at the Jewish Foundation was created to ensure that a permanent, restricted endowment fund would be available to enhance the quality of life for future generations of Jewish women and their families in Greater New Haven, in Israel, and around the world.

The society was created by 100 women who each contributed a minimum of \$1,000 to establish the original endowment. Annual grants have been made from this fund since 1998. In 2002, **Women of Vision Society Too** was launched to allow additional members of the community the opportunity to participate.

Each year, the Women of Vision Grants Committee makes awards that are funded from the Women of Vision Society endowment. Since 1998, over **\$220,000** has been awarded for programs and projects of concern to Jewish women. (See pages 30-32 and 61-63)

PROFESSIONAL DEVELOPMENT GRANTS

Thanks to the Judith A. Kaye Fund for Teachers in Jewish Education and the Community Education Funds, the Jewish Foundation is thrilled to offer **professional development grants for Jewish educators**.

These grants help ensure that classroom educators in local Jewish schools can attend workshops and conferences to develop their teaching skills. The grants help local Jewish organizations provide educational opportunities to instructors and the community.

Applicants must be either a) classroom educators employed in Jewish education in a local Jewish school or synagogue or b) a local Jewish school or synagogue. Eligible programs must be hosted by a recognized Jewish institution or reputable educational institution.

SECURITY GRANTS INITIATIVE

Thanks to the Arthur Eder Family Fund, in memory of Arthur & Yvette Eder, **\$787,000** in security grants has been awarded in the Greater New Haven Community.

COMMUNITY GRANTS FOR THE JEWISH ELDERLY

These grants benefit innovative and new programs and projects for Jewish elderly currently residing in greater New Haven. In 2022, **\$169,000** in grants were awarded to Jewish Family Service of Greater New Haven, Chabad of the Shoreline, and The Towers at Tower Lane. 🌟

GRANT SPOTLIGHT

GRANTS FOR THE JEWISH ELDERLY

Getting old may not be easy...but, with the help of the Jewish Foundation of Greater New Haven, it's getting easier. Since it was established in 2020, \$549,000 in Grants for the Jewish Elderly has been awarded to a variety of Jewish organizations and agencies for new and innovative projects and programs that enhance the quality of life for the Jewish elderly in the New Haven community.

The need for such programs is critical—and, with the Baby Boomer cohort in the US projected to exceed 20% by the year 2030, the need for resources for older adults is expected to continue to increase.

The Jewish Foundation's Grants for the Jewish Elderly is here to meet that compelling need, thanks to the generosity of the former Jewish Home Building Fund Corporation, as well as several funds of the Jewish Foundation of Greater New Haven, including the Isaac & Mary Liveten Fund for the Jewish Home for the Aged; Marion Litsky Fund for the Jewish Elderly; Irvin Shiner 75th Birthday Fund for the Jewish Home for the Aged; Benjamin & Freda Cohen Memorial Fund for Jewish programs for the Frail & Elderly; Eva Kahn Fund for Elderly Services; Harry Braffman Fund for the Jewish Elderly; and the Leo Links Fund for the Jewish Elderly

\$549,000 in Grants for the Jewish Elderly has been awarded to a variety of Jewish organizations and agencies to enhance the quality of life for the Jewish elderly in the New Haven community.

In 2022, \$169,000 in Grants for the Jewish Elderly were awarded to three deserving agencies for new and innovative programs: Jewish Family Service of Greater New Haven, The Towers at Tower Lane, and Chabad of the Shoreline.

“We have been pleased to secure continued funding to support our community's Jewish aged population through the grants awarded to the Towers, JFS, and Chabad of the Shoreline,” said Craig Sklar, Chair

of the Foundation's Jewish Elderly Grants Committee. "We hope to continue to address the many needs of our geriatric population by providing food support, socialization, and social work services."

Jewish Family Service of Greater New Haven was awarded a grant for their Care Navigators Program, a support program open to all aging adults regardless of socioeconomic status, faith, culture, or race. The program provides the assessments, referrals, and support required to keep the elderly safely in their own homes or appropriate new housing. In this way, they will be living physically, mentally, emotionally, spiritually, and socially to their fullest extent.

"We are grateful to the Foundation for supporting the creation of a platform where all older adults and their



families are supported," Elanit Lender, LMSW, the aging adult and community outreach coordinator for JFS. "Aging levels the playing field. We all age and this grant supports aging with dignity for folks of all walks of life. If an individual has a healthcare crisis, this levels the playing field in a way that is beyond quality of life measures. Care Navigators helps all people to navigate and understand the best options during the crisis or in a planful manner to avoid any incidents."

The Towers at Tower Lane is putting its grant to good use with plans to create a new community garden on the senior living facility's campus.

The garden will replace our 13,300 square foot basketball court which is decaying and unusable. The new garden will transform our campus and provide both much needed green space and many other features," says Jennifer Baron Bayer, The Towers' Associate Vice President, Strategic Initiatives.

The community garden will include raised wheelchair accessible beds enabling seniors to plant while remaining seated, an herb garden, a chicken coop for fresh eggs, a water feature and reflection area; a shaded gathering area, a bocce court, a dog run, and, a play area for all those visits from grandkids.

The garden will be a hub for both education and volunteerism. Towers partner Morrison Living will provide nutritional workshops. Local schools and camps may volunteer and learn in the garden. In addition, says Bayer, "We are delighted to share the bounty of our garden with those who might be in need."

Of course, all this would not be possible without community help.

"The Towers is grateful for the support of the Environmental Protection Agency's Environmental Justice Grant Program and the Jewish Foundation of Greater New Haven's Elderly Grant process for major funding to help this project get underway. The Towers also thanks its private donors and The Jewish Federation of Greater New Haven's Impact Grant Program for additional funding," Jennifer notes.

Chabad of the Shoreline received a Grant for Jewish Elderly for its Smile on Seniors program which links volunteers with homebound or lonely elderly people for weekly visits. The goal is to bring them joy and stimulation, reduce isolation, and increase socialization. SOS also hosts Intergenerational projects that uplift and invigorate the elderly — and benefit volunteers, who learn from their elders' wisdom and life experience.

"We hope ultimately to match every Jewish senior in need on the Shoreline with a volunteer," says Rabbi Yosef Yaffe, spiritual leader of Chabad of the Shoreline. "The Jewish elderly on the Shoreline critically need companionship and friendship, especially since COVID has disrupted their safety nets and social fabric."

Chabad presented to the Foundation a proposal to create the Smiles on Seniors program and, in October 2021, they hired a senior services coordinator, Melanie Van Emmenes, to create a database of every senior facility on the Shoreline. Van Emmenes visits the facilities that have Jewish residents, bringing Chanukah, Purim and pre-Pesach gift packages to residents and coordinating several holiday events. 🌸

SCHOLARSHIP OPPORTUNITIES



COLLEGE SCHOLARSHIPS

MARY TAYLOR FRIEDLER MEMORIAL SCHOLARSHIP FUND

This fund was established in 1991 with an initial gift from Saul Friedler in memory of his wife to provide a college scholarship to a Jewish high school senior from Greater New Haven. The scholarship requires an essay concerning what peace, justice, and righteousness mean to you and your Judaism. Awards average \$500 and are based on the strength of the essay. This scholarship is needs-based.

STUART J. DRELL SCHOLARSHIP FUND

The Stuart J. Drell Scholarship Fund was established in 2001 at Congregation Beth Israel in Scotch Plains, New Jersey. When Renee Drell relocated to Connecticut, she transferred the fund to the Jewish Foundation of Greater New Haven, and it now awards college scholarships to high school seniors as well as current college students. Awards are \$1,500 and applicants must be from a Jewish household in Connecticut.

Awards are based on the strength of the application (which requires an essay) and financial need.

EMMA KOHN PODOLOFF SCHOLARSHIP FUND OF THE NATIONAL COUNCIL OF JEWISH WOMEN'S GREATER NEW HAVEN SECTION

The Emma Kohn Podoloff Scholarship Fund of the National Council of Jewish Women's Greater New Haven Section at the Jewish Foundation sponsors scholarships to advance the scholastic and vocational education of Jewish high school seniors from Greater New Haven. An academic average of "B" or better and verified financial need qualifies a student to be considered.

Awards average \$1,500. The application includes an essay and three recommendations. Awards are based on the strength of the application and financial need.

All applications must be completed online by May 15, 2023 and are confidential and anonymously reviewed by a scholarship committee.

SYNAGOGUE SCHOOL SCHOLARSHIPS

Through the generosity of a donor in our community, this initiative provides need-based assistance for New Haven-area synagogue schools. Assistance from this initiative supplements other scholarships.

ONE HAPPY CAMPER NEW HAVEN

Needs-Blind: The Jewish Foundation, in partnership with the One Happy Camper program of the Foundation for Jewish Camp, as well as an anonymous donor, is thrilled to offer needs-blind grants of \$375-\$1,000 for **first-time campers** from Greater New Haven to attend any one of over 200 traditional and specialty Jewish overnight camps nationwide.

Need-Based: The Jewish Foundation, in partnership with an anonymous donor, is thrilled to offer needs-based financial assistance for campers from Greater New Haven to attend Jewish overnight camps nationwide.

ISRAEL EXPERIENCE SCHOLARSHIPS

The Jewish Foundation Israel Experience Scholarship Program provides local Jewish students ages 14-19 the opportunity to participate in an Israel experience to develop and enrich their Jewish education and reinforce their Jewish identity.

The Jewish Foundation provides scholarships for both short-term (minimum of three-week program) and long-term organized Israel educational programs.

An essay and two recommendations are required. All applications are confidential and anonymously reviewed by the Israel Experience Scholarship committee.

ZOE SCHULMAN'S NCSY TRIP TO ISRAEL & ITALY

I was fortunate to receive a scholarship from the Jewish Foundation of Greater New Haven towards the cost of my National Conference of Synagogue Youth (NCSY) trip to Israel and Italy this past summer.

The trip began in Geneva, Switzerland, where we spent part of a day sightseeing around the city and driving through the French Alps (which were gorgeous) en route to Milan, Italy. We spent a beautiful Shabbos in Venice walking along the canals and learning about the history of the Jewish Ghetto of Venice. We subsequently traveled around the north stopping in Tiviera, Haifa, Netanya, Rechovot, Rishon LeZion, and Tel Aviv. Each of these places was beautiful, and I enjoyed all the memorable experiences I was able to take part in. Especially fun were my surfing lessons in Haifa at the

Mediterranean Sea - I even caught a wave - and also, biking along the shore in Tel Aviv.

Our last days of the trip were spent wandering in Jerusalem eating incredible foods and shopping on Ben Yehuda street and in the Shuk. GIVING TIPS

IRA CHARITABLE ROLLOVER

The IRA charitable rollover creates an opportunity for donors to establish an endowment or make an outright charitable gift to a charitable organization. Your rollover can be directed for a capital campaign gift or current needs, or restricted for endowment purposes. Your gift can be earmarked for your synagogue, a local Jewish agency, Jewish education, or any program or organization that is important to you. In addition, if you have a secondary, smaller IRA that is not a necessary income source, this is an opportunity to donate that IRA to our community and make a significant and much-needed impact.



12 THINGS TO KNOW ABOUT THE IRA CHARITABLE ROLLOVER

- 1 The distribution from your IRA must be made directly to the charitable organization.
- 2 You must be 70½ or older at the time that the distribution is made.
- 3 The IRA charitable rollover opportunity is permanent; you can do it this year and every year.
- 4 The maximum amount that can qualify is \$100,000.
- 5 The IRA charitable rollover will satisfy your required minimum distribution.
- 6 You can roll over more than your required minimum distribution and in addition to your required minimum distribution (up to \$100,000 to charity).
- 7 The amount of the IRA charitable rollover does not need to be reported as income on your federal or Connecticut income tax return.
- 8 Only distributions from traditional and Roth IRAs qualify.
- 9 To qualify, the distribution can only be for charitable purposes and cannot be designated for a donor-advised fund, supporting organization, or private foundation.
- 10 Thanks to the 2022 Omnibus Bill, a one-time qualified IRA charitable distribution of \$50,000 is permitted for a charitable gift annuity or charitable trust.
- 11 No goods or services can be received in exchange for the distribution (e.g., tickets or dinner).
- 12 In most cases, you will need to contact your IRA plan administrator or financial institution.

STOCK GIVING

When you donate long-term appreciated securities, you can claim a charitable income tax deduction for the fair market value of the securities on the date of transfer, no matter what you originally paid for them. You pay no capital gains tax on the transfer.

Donating the stock results in no capitals gains tax being paid, a larger itemized deduction, and more money for the charity of your choice. That's a win-win!

IF THE SECURITIES HAVE APPRECIATED

If the securities originally cost \$2,000 and now have a fair market value of \$10,000, you do not pay tax on the \$8,000 gain. You may, however, claim a charitable income tax deduction for the full \$10,000.

IF THE SECURITIES HAVE DEPRECIATED

In this case, it is usually better to sell first. By doing so, you can take the capital loss for tax purposes and then donate the cash.

	Gift of \$10,000 cash	Gift of \$10,000 stock
Initial cost basis of securities/appreciation	N/A	\$2,000/\$8,000
Capital gains tax saved or paid (assumes 20% rate)	N/A	\$1,600
Personal income tax savings (0.35 × amount donated)	\$3,500	\$3,500
Net tax savings	\$3,500	\$5,100

This example assumes 35% tax bracket, a cost basis of \$2,000, that the investment has been held for more than a year, and that all realized gains are subject to a 20% long-term capital gains tax rate. This does not take into account any state or local taxes.

Consult your professional advisor concerning your tax plans.

CONSIDER BUNCHING!

If you do not itemize deductions, consider bunching your donations instead.

When you bunch donations of stock to a donor-advised fund, your itemized deductions can go beyond the current standard deduction amounts for 2022 (\$12,950 for individuals; \$25,900 for joint filers).

By doing so, you can claim a charitable income deduction this year, and then distribute the monies to the charities of your choice over several years.



WOMEN OF VISION & WOMEN OF VISION TOO

The Women of Vision Society was created in 1996 in order to ensure that a permanent, restricted endowment fund would forever be available to enhance the quality of life for Jewish women and their families in Greater New Haven. One hundred women contributed \$1,000 each to establish the original endowment, from which grants have been made annually since 1998.

The Women of Vision Society Too initiative was launched in 2002 to allow additional members of the community the opportunity to help increase the monies available for grants that support scholarships for Jewish women to study in Israel or do graduate work in a Jewish-related subject, speakers for Jewish women's programming, and projects of concern to the Jewish home and family.

Since 1998, over \$220,000 in grants has been distributed.

WOMEN OF VISION GRANT RECIPIENTS

JEWISH FEDERATION OF GREATER NEW HAVEN DIGNITY GROWS

LOCAL

Human dignity is not a luxury, yet many women suffer from period poverty, lacking money to purchase basic menstrual and hygiene products. This initiative mobilizes volunteers to organize, assemble, and distribute free, reusable totes filled with a month's supply of these basic necessities. This program also partners with local organizations, such as Jewish Family Service and the Diaper Bank, to get the monthly supplies to the women who need them.

YASHAR LACHAYAL FEMALE HAREIDI LONE SOLDIER PROJECT

ISRAEL

This organization has supported lone soldiers in the Israeli Defense Forces since 2006, and ultra-orthodox lone soldiers since 2019. The support of female, ultra-orthodox lone soldiers is their newest initiative. These young women are soldiers from ultra-orthodox families who don't receive support from their families due to their decisions to serve in the Israeli Defense Forces. These girls need a place to live and a support system that will guide them. They need a home for them while they are on leave, assistance with integration into the IDF, and a support system during and after their service.

CAMP LAURELWOOD CL AT THE WELL

LOCAL

Camp Laurelwood is a Jewish summer overnight camp in Connecticut that serves hundreds of young women. This initiative incorporates programming centered around their development, care, and empowerment. Camp Laurelwood plans to provide a space and sessions throughout the summer for female staff and campers, administered by female year-round staff members.

THE TOWERS AT TOWER LANE HORTICULTURE THERAPY FOR COGNITIVELY IMPAIRED OLDER ADULTS

LOCAL

20 residents and 20 volunteers will meet bi-monthly for 1.5 hours to design floral arrangements. The act of creating brings social, emotional, and cognitive value to residents and volunteers. Participants enjoy continued stimulation viewing their creations in their apartments. Volunteers use the extra plant materials to make floral displays for the common area, uplifting everyone.

B'NAI B'RITH YOUTH ORGANIZATION BBYO BUILDING SISTERHOOD

LOCAL

BBYO delivers impact by bringing teens together in powerful Jewish environments. The most well attended and widely implemented gathering moments in BBYO are their regional conventions, which always have special moments for BBGs (female-identifying participants)

to bond as a community, celebrate and grow together through programs rooted in tradition and self-love.

THE ISRAELI CENTER FOR CULT VICTIMS SINGLE-PARENT MOTHERS' SEMINAR ON PERSONAL EMPOWERMENT AND ECONOMIC GROWTH FOR CULT SURVIVOR WOMEN

ISRAEL

Many victims lack education and training, knowledge and professional working tools. The distress only intensifies when they are single-parent mothers as their children and household depend on them financially. This seminar is intended to help victims rehabilitate, accumulate practical knowledge, and acquire useful tools, thus restoring their independence and producing economic stability.

HAIFA RAPE CRISIS CENTER (HRCC) YOU ARE NOT ALONE

ISRAEL

This project provides an emotional resilience group for mothers whose children have been sexually harmed or abused. Groups run for 25 sessions of 1.5 to 2 hours each. They are overseen by two professionally trained facilitators, and can accommodate up to 10 women.

KALEIDOSCOPE NEXT STEPS FOR WOMEN

ISRAEL

This initiative will join 22 early childhood educators of different religious expressions and cultures in

professional training that fosters their appreciation for one another and for diversity. The project includes workshops, resources, and mentoring, enabling them to foster appreciation for diversity in their kindergartens and to become diversity education facilitators.

SHAALEI TIKVA MOTHER-DAUGHTER BAT MITZVAH PROGRAM

ISRAEL

Bat Mitzvah girls and their mothers and grandmothers will celebrate the event in style, partaking in the holy ceremony of 'separating the dough'. The generations will rejoice together, observing this unique women's ritual, and then travel to Rachel's Tomb to identify as Jewish women, strengthening their mother-daughter bonds of womanhood.

JSCREEN AT EMORY UNIVERSITY JEWISH FEDERATION & JCC OF GREATER NEW HAVEN JSCREEN FUND

LOCAL

The collaboration with the Jewish Federation and JCC of Greater New Haven will provide education and access to genetic screening and counseling regarding the risk of developing hereditary cancer or having a child with a genetic disease. These goals will be accomplished through a one-day symposium and other outreach efforts. 🌟



WOMEN OF VISION GRANT SPOTLIGHT

YASHAR LACHAYAL

Yashar LaChayal launched the Female Haredi Lone Soldier Project initiative in 2019 to support female ultra-orthodox lone soldiers in the Israeli Defense Forces (IDF). These young women aren't supported by their families because their decision to serve in the IDF. The Lone Soldier Project provides them with housing and a support system during and after their service.

Annie* is a female lone soldier who comes from an ultra-orthodox home. When she chose to enlist in the army, she was emancipated from her family and community.

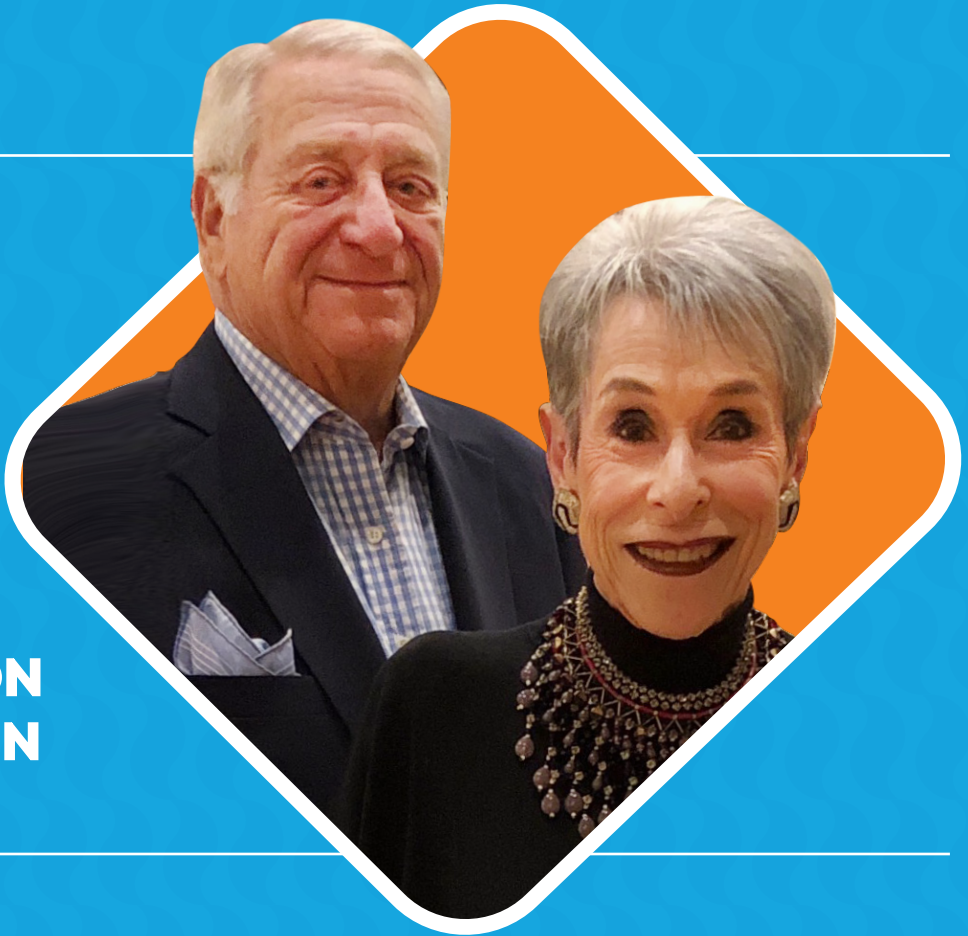
Annie serves in the Field Intelligence Corps. She's a hardworking, quiet, motivated soldier. An army social

These funds allow you to recommend distributions to any qualified tax-exempt organization. Think of it as a charitable checking account. The Foundation administers the fund, vets grantees, and invests the assets.

This is a wonderful way to involve the family in giving—together the donor and their family can choose to distribute their funds to charitable organizations that they are passionate about.

These funds can be established with a minimum gift of \$10,000.

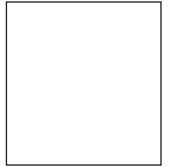
